CHAPTER FOURTEEN

1965 DEFINITIVE ISSUE.

The first definitive issue for Malaysia came in two parts. In line with the 1960 policy decision (see Chapter 9), the values from 25c. upwards were issued as Federal stamps to be used throughout Malaysia as a means of emphasising the unity of the Federation (as well as keeping costs down). The lower values continued to be issued separately for each state. At the time of conception, this included Singapore, but the Singapore designs were never printed as a result of Singapore's departure from the Federation in 1965.

1. FEDERAL HIGH VALUE STAMPS.

9 September 1965.



















Designed by A. Fraser-Brunner, this issue comprised eight counter sheets.

Design:

The eight 25mm x 36mm stamps showed various Malaysian birds:

25c.: Crested Green Wood Partridge (Burung Siul, Rollulus roulroul);

30c.: Blue-backed Fairy Bluebird (Murai Gajah, Irena puella malayensis);

50c.: Black-naped Oriole (Burung Kunyit Besar, Oriolus chinensis maculatus);

75c.: Rhinoceros Hornbill (Enggang Badak, Buceros rhinoceros);

\$1: Zebra or Barred Ground Dove (Merbok, Geopelia striata);

\$2: Male Great Argus Pheasant (Kuang, Argusianus argus) displaying to female;

\$5: Asiatic Paradise Flycatcher (Murai Ekor Gading, Terpsiphone paradisi affinis);

\$10: Blue-tailed or Banded Pitta (Burung Pachat, Pitta guajana).

The Bahasa Malaysia word "Burung", meaning "bird" was shown on the stamps in Romanised Malay as "Burong".

Printing:

They were printed by Harrison & Sons using four-colour photogravure, with the exception of the \$2 which was three-colour. According to the Crown Agents Plate and Die register, the 50c. was printed from cylinders, the remainder from plates. The 200-set printer's plate had two panes, 1A and 1B, giving counter sheets of 100 (10 x 10). The only replacement plate recorded was the 25c. red plate, where combinations 1A 2A 1A 1A and 1B 2B 1B 1B were reported.

Sheet markings included the pane numbers below R10/9, rectangular colour dabs (boxed in the background colour) to the right of R10/10 (the right-hand side of the box was usually guillotined off).

Paper:

The low fluorescence, white chalky paper normally had watermark Multiple PTM upright. All values except 75c. and \$10 exist with inverted watermarks. ¹ The first printing had Gum Arabic (GA) adhesive on the back. All later printings of the 25c., 30c., 50c., \$1, \$2 and \$5 received poly-vinyl alcohol (PVA) gum. Various means of identifying the gum have been suggested. For example, the GA version has patchy gum, while the PVA version has a fine, textured finish. However, a sideways watermark low value may be used as a comparator as it only exists with PVA gum.

Perforation:

The comb perforations measured 14.5 x 14.4. On sheets from both panes, the left- and right-hand margins were imperforate with a single extension hole, the top margin was imperforate and the bottom margin was perforated through. This suggests that the sheets were guillotined before perforating and that a single-sheet-width comb started at the top and worked downwards. The 75c. exists with misplaced perforations.

Where two plate numbers are quoted, the lower numbered plate was replaced and destroyed on 22 February (1968?), together with unidentified additional rejected plates 7094, 7099, 7177.

Imperforate colour separation and progressive proofs for this issue on watermarked paper came onto the open market between 1981 and 1985. A set of 43 imperforate progressive proofs (5-6 of each value) were offered for auction in 2000. Two imperforate sheets, probably proof sheets, each of the 25c., 30c. and 50c. stamps are known to have come on the market. The existence of one imperforate \$10 sheet was reported.² Usually offered in pairs, the following combinations have been recorded, but others may exist:

1. Crown Agents Requisition G&P/Malaya/5/01792/1.

Black and white photographic essays were submitted and the samples in the British Library Philatelic Collection were annotated "Records only" on 5 March 1965. Colour essays by Harrison of all values were submitted to A. J. D. Simpson, the Crown Agents Inspector of Stamps. The 25c. was approved on 26 April "subject to improvement of the black working on beak, claws and caption". A 25c. "running proof" (with no apparent differences) was approved by him on 21 May, together with the 30c. and \$5. The 50c. was rejected on 29 April but approved on 21 May after lightening of the grey on the feathers of the wings and tail. The 75c. was approved on both 30 April and 6 July, the latter having the bird's name emboldened. The \$1 was approved on 14 May "subject to modifications referred to in our letter of 13 May 1965" (It is not known what these were). A running proof with no apparent differences was signed on 1 June. The \$2 was rejected on 29 April but approved with lighter grey feathers on 21 May. The \$10 was rejected on 29 April but approved on 4 June after the tree roots on the ground were changed from white to grey. Harrison & Sons were paid £4960 for the preparation of printing plates, which were held by Crown Agents when not in use.

The stamps of the initial order were shipped in two batches on 1 July 1965 and 15 December 1965. Specimens were produced for GPO (496 + 6), PP (297 + 3 for CO), CA (1), CB (1), BM (1), CI1 (1), MH (1), H1 and HM. The balance of 900 specimens were to go to Crown Agents Department G10 (Bureau) Publicity. Quantities of sheets ordered and supplied, in parcels of 500 sheets, were as follows:

Notes: It is assumed that Singapore only received an initial "new issue" supply in the 1 July 1965 distribution and none in the December distribution, Singapore's share of the December distribution being transferred to Kuala Lumpur stock. This is borne out by the substantial shortfall in delivered quantities compared with ordered quantities. The bulk of the July supply, beyond philatelic needs, was likely to have been transferred to Kuala Lumpur shortly after independence in August 1965. Issued 9 September 1965. GA gum paper.

Order for reprinting 29,350 sheets of 25c. (29,250 for Malaya and 100 for the Bureau), 69,350 30c. (69,250 for Malaya and 100 for the Bureau) and 72,350 50c. (59,250 for Malaya, 5000 for Sabah, 8000 for Sarawak and 100 for the Bureau), to be supplied in parcels of 500 sheets.

Malaya was supplied 32,000 25c., 64,000 30c. and 62,000 50c. in two batches on 8 February and 3 July 1967. Sabah and Sarawak were supplied the ordered quantities of 50c. on 9 February. The Bureau received ordered quantities.

Notes: Bureau released them on 2 April 1968.

Order for 750 sheets each of 25c., 30c. and 50c. Supplied by sea from the Bureau on 18 November 1966.

Order for 100 sheets each of 25c., 30c. and 50c. Supplied by sea from the Bureau on 18 December 1967.

5. Reqn. G&P/Malaya/8/38791/1 (1968).

Order for reprinting 14,600 sheets of \$1 and 7900 sheets of \$2, to be supplied in parcels of 500 sheets. Malaysia was supplied the ordered quantities on 26 November 1968. The Bureau received 100 sheets of each.

Notes: The Bureau released these on 7 January 1969. From this printing onwards, PVA gum was used.

Order for reprinting 7500 sheets of 25c., 6650 sheets of \$1,6750 sheets of \$2 and 1250 sheets of \$5. Malaysia was supplied the ordered quantities on 7 May 1969. The Bureau received 100 sheets of each.

Notes: The Bureau released the 25c. and \$5 on 13 May and the \$1 and \$2 on 24 June.

Order for 100 sheets of 25c., 150 sheets each of \$1 and \$2 and 300 sheets of \$5. Supplied from the Bureau 18 March 1969.

Order for reprinting 8550 sheets of 25c. and 5850 sheets of 30c. Malaya was to receive 7200 sheets of 25c. and 3400 sheets of 30c., while Sabah was to receive 11 sheets of 25c. and 2200 sheets of 30c. Sarawak was not allocated any of this printing. The Bureau received 250 sheets of each. Delivery quantities and dates were not recorded. Notes: The Bureau released this printing on 20 January 1970. PVA paper.

9. Reqn. G&P/Malaya/? (1970).

Order for reprinting an unknown quantity of \$1 and \$2.

Notes: The Bureau released this printing on 27 May 1970. It does not appear in the surviving Crown Agents Requisition Books. PVA paper.

There may have been other Requisitions after the last one recorded in the Requisition Books.

Issue and Withdrawal:

The official first day cover, sold at 10s., showed a line drawing of the Paradise Flycatcher. No first day postmark was used. Although the Singapore issue was never released, the rest of the issue was given a philatelic release there, Malaysia and Singapore stamps continuing to be usable in both countries.

The agreement on inter-validity of Singapore and Malaysian stamps ceased in February 1967 and the issue was withdrawn from sale in Singapore on that date. The issue was withdrawn in Malaysia on 30 August 1970 (25c to 75c.) or 15 November 1970 (remainder).

The issue was invalidated for postage from 1 October 1987.

Pos Malaysia issued a blue softback album for collectors of this issue with spaces for both the high values and all the state low values.

Orchids Low Value Definitives.







































Designs:

Designed by A Fraser-Brunner, the seven 35mm x 25mm designs each bore a different orchid, with both Malaysia and the state name in both Roman and Arabic scripts. Sabah and Sarawak received issues in the State series for the first time. Designs were produced for Singapore but these were never issued because of the break between Malaysia and Singapore shortly before this issue appeared. State names were changed with effect from this issue in the case of Johore ("Johor"), Malacca ("Melaka"), Negri Sembilan ("Negeri Sembilan"), Penang ("Pulau Pinang") and Singapore ("Singapura") ¹⁴.

The orchids shown were:

- 1c.: Kinta Weed (Anggerek Pensel, Vanda hookeriana),
- 2c.: Bamboo Orchid (Anggerek Bambu, Arundina graminifolia),
- 5c.: Slipper Orchid (Anggerek Kasut, Paphiopedilum niveum),
- 6c.: Forest Bamboo Orchid (Anggerek Buloh Hutan, Spathoglottis plicata),
- 10c.: Scorpion Orchid (Anggerek Kesturi, Arachnis flos-aeris),
- 15c.: Foxtail Orchid or Squirrel's Tail Orchid (Anggerek Lilin or Anggerek Ekor Tupai, *Rhyncostylis retusa*),
- 20c.: Lundu Orchid (Anggerek Anak Bulan, *Phalaenopsis violacea*).

The Lundu Orchid was adopted in 1983 as the State Flower of Sarawak and renamed "Orkid Normah" in honour of YB Toh Puan Datuk Patinggi Haijah Normah, wife of the Yang di-Pertuan Negeri of Sarawak.

The Sultan's portrait or State coat of arms appeared at the right of the stamp. The portrait or coat of arms used by each state were as shown below. Where a portrait was used, the coat of arms was shown in a box at the bottom right-hand corner, whereas, in the other cases, the state name panel continues to the right-hand end of the stamp.

The Singapore coat of arms intended to be used was the stars and crescent shield with supporters over a ribbon containing the legend "MAJULAH SINGAPURA", which translates as "Advance Singapore".

Printing:

They were printed in counter sheets of 100 (10 x 10) by Harrison & Sons Ltd using 3, 4 or 5-colour photogravure. The heavily-used 6c. and 15c. stamps were printed on the reel-fed Thrissell press ¹⁵, whilst the other lesser-used values were printed on the sheet-fed Rembrandt press.

On some early GA printings, fluorescent magenta (1c.) and fluorescent bright purple (20c.) were used. Colour intensity varies substantially. Notable examples noted were 6c. mauve (ranging from pink to lilac shades on Sabah, for example) and 15c. green. Other shades are recorded below where appropriate.

Printing plates:

All values come from two-pane plates, the upper pane being marked 1A (times the number of colours used) below R10/9 and the lower similarly marked 1B. Below R10/1 on each pane were solid squares of each colour in the order shown above, surrounded by a single frame line in the last colour stated. The frame was 9-10mm below the state name box on the stamp. This resulted in the bottom of the colour block normally being guillotined off and the appearance of the bottom part of the 1A pane block about 10mm above R1/1 on the 1B pane. The 1c. block shows a broken frame line at the top left. The green square was omitted on early sheets of the Malacca 15c. GA (sheet number range seen was from 008560 to 010771). The green square reappears later but the number range overlaps (010769 of the same stamp seen) suggesting that sheets were numbered after printing, not necessarily in printing order.

The coloured plates were common to all states. The 200-set cylinders used were as follows (Harrison cylinder number and colour name in brackets):

A separate unique black plate was produced for each state containing the country name and head or crest, but there is evidence that they came from a common master photographic stage ("multi-positive"), as the same flaws appear on more than one state. Similarly, within a state, some flaws were common to all values whilst others show different flaws and states of flaws. There were two black plates for each state, the 20c. having a separate plate incorporating parts of the design. The "black" features on other values were printed by the grey plate. It should be noted that the colour used for the state information (state name and head or emblem) varies widely from grey and brown-black to intense black. The head was said to be the best means of identifying these shades.

Selangor 20c. plate 64 was destroyed on 15 February 1968 having been replaced by 139. It is not known whether the pane numbers were changed to 2A/2B.

The suggestion that there were two plates, dark grey (possibly a lightly etched black plate) and black, taken from the same master, resulting in the plate numbers being superimposed one over the other, can now be discounted. A more likely answer is that the touch-up work was imperfect.

The two reel-fed values had mauve (6c.) or magenta (15c.) H-shaped perforation check boxes printed above the extreme left of 1A R1/5 and below 1B R10/5 (encroaching into the margins of the adjacent stamps). See the section on Perforations below for details of how these boxes were used.

All the plates were produced photographically from glass and film negatives, taken from positive colour separations.

Sheet numbering:

Most sheets seen have not been numbered, and no mention of numbering was found in the Crown Agents records, but this may have been an automatic feature of the Thrissell press, as many sheets of the 6c. and 15c. appear to have been numbered in black serif numerals (Sabah 6c. 1B and Sabah 15c. 1A sheets have been seen without sheet number). The sheet number appears upright in the top margin (believed to be from 1A panes - Sabah 6c. 03338 seen) or inverted in the bottom margin of 1B panes below R10/6 (008560 to 010771 seen on Malacca 15c., 021010 to 043945 seen on Sabah 15c.). In some cases, a black vertical line appears after the number on the Malacca 15c., presumably caused by part of the stamping device.

Sarawak had a tradition of numbering its sheet of stamps and a 1c. sheet has been seen bearing number 139 above R1/10. It is likely that all sheets shipped to Sarawak were numbered, but not those supplied to the Crown Agents Stamp Bureau.

Other sheet markings:

Other sheet markings known include:

15c. 1B Below R10/2-3: Alignment crosses. (Normally guillotined off).

Below R10/6: Magenta marks, caused by plate defects. (Usually guillotined off).

Below R10/7: "G 1 RED" printer's instructional mark in magenta. (Usually guillotined off).

Alignment crosses. (Normally guillotined off).

Paper:

Initial printings were on a low-fluorescence white paper giving a blue white fluorescent reaction under ultra-violet light. The intensity of the fluorescence varies widely. The 18 November 1970 and 7 December 1970 printings used a highly fluorescent whiter paper and reverted to upright watermark.

Watermarks:

The paper normally has watermark Multiple PTM upright, but some inverted watermarks are known, including 1c. Johore, Pahang, Perak, Selangor; 2c. Negri Sembilan, Perak; 5c. Penang, Trengganu, 20c. Selangor.

Two 1970 printings had watermark sideways reading down. Crown Agents release dates with this watermark were:

It should be noted that there were no sideways watermark printings for the stamps printed on the Thrissel reel-fed press.

Gum:

The adhesive was originally gum Arabic, but about half of the printing released by the Crown Agents on 2 April 1968 (that part printed in 1967, plus 6c.), and all subsequent printings, used poly vinyl alcohol (PVA). Whilst it is difficult to identify a stamp in isolation, when you compare mint stamps, Gum Arabic was more glossy with adhesion spots, whilst PVA was less glossy and more highly textured. It was reported that PVA had a slight yellowish tinge added to assist the printer to identify gummed paper, but this is not readily apparent.

Perforations:

The perforation measures 14.5. Comb perforators were used, except in the case of 6c. and 15c. which were perforated in the web during printing. To enable continuous monitoring of the accuracy of the perforating, mauve (6c.) or magenta (15c.) H-shaped check boxes were printed above the extreme left of 1A R1/5 and below 1B R10/5 (encroaching into the margins of the adjacent stamps). The perforator punched a 5mm hole once in each rotation and, if it was correctly sited in the inner part of the H, all was well.

On both panes of the 6c. and 15c., the left-hand margin was imperforate, top and bottom margins have a single extension hole and the right-hand margin was perforated through. On both panes of the other values, the right-hand margin was imperforate, top and bottom margins have a single extension hole and the left-hand margin was perforated through. From that, it can be concluded that the 6c. and 15c. stamps were perforated starting from the left-hand side of the sheet, moving the perforating head towards the right. The others were perforated from right to left.

Droofe

The usual range of plate proofs will have been produced for production and presentation purposes, and uncut proof sheets of 200 were produced for display purposes. Some have appeared on the open market, including the following items. The Johore 1c. exists imperforate from a plate proof sheet (I.S.C. 172j). "Stateless" imperforate proofs exist for all values. Is I.S.C. also lists the Kelantan 5c. (I.S.C. 102g), Negri Sembilan 2c. (I.S.C. 83c), Pahang 15c. (I.S.C. 95a), Perlis 10c. (I.S.C. 45f) and Sarawak 6c. (I.S.C. 227c) imperforate, assumed, in the absence of other provenance, to be from the same source. The Kelantan 1c, 5c., 10c. and 15c. values exist as "working proofs" mounted on Harrison headed cards for display purposes. The Trengganu head plate exists as a block of eight on a Harrison presentation card. 20

Requisition history:

The printing history was recorded in the Crown Agents Requisition Book for most of the issue's history, but expires at the end of 1969. Orders were normally supplied in parcels of 500 sheets. Quantities below were in sheets.

This Crown Agents Requisition covered the production of the first Malaysia low-value issue, intended to eliminate the remaining State postage stamps not bearing the new country's name. The designs were submitted to the Crown Agents Inspector of Stamps. Black-and-white photographic essays were approved on 27 May 1965 for the 1c. Malacca, Penang, Sarawak, Singapore and Trengganu, 2c. Kedah, 5c. Perak, 6c. Kelantan, 10c. Selangor, 15c. Johore, Perlis, 20c. Pahang. The 1c. designs for Negri Sembilan and Sabah were rejected (This selection of designs would have covered all 98 state and value combinations). The Perlis duty plate was approved on 3 July. The Perak duty plate was approved on 8 July "subject to colour being grey-black", together with 1c. key plate and Perak 1c. final design, subject to the same remark. The Selangor duty plate, 2c. key plate and Selangor 2c. combination were approved on 20 July. The approved proof appears to use jet-black despite the previous comment. Sabah and Sarawak 5c. duty plate proofs were approved on 22 July. The Sabah proof was annotated to give instruction to darken the flower stem, which was originally bright pink. The Singapore duty plate and 10c. combination was approved on 8 July. The Trengganu duty plate was approved on 30 July. Finally, the 6c. key plate and Pahang duty plate were approved on 4 August.

The order was not completed until October 1966. Quantities of sheets ordered and produced were as follows:

It should be noted that in some cases a reprint under the same contract had to be ordered due to major shortfalls in some of the production quantities of the 15c. and 20c. Whilst it was quite normal for the Requisition Book to record more than one shipment date against an order, the fact that this issue has been specifically annotated "Reprint" suggests that the substantial shortfall was noticed after the printer had ceased production of a specific value and that he was instructed to make it good in some but not all cases. Several entries against other contemporary issues suggests a general tightening up of control of stamp orders in the mid-1960s, whereas prior to this the quantity delivered rarely bore any resemblance to the quantity ordered!

2. Stamp reels (Reqn. G&P/Malaya/6/01297/1) (1966):

The 10c. orders listed above included a quantity of sheets of stamps for conversion into reels in the case of states having such machines. Containing 1000 stamps per reel, orders were Johore (50), Negri Sembilan (50), Penang (60), Perak (50) and Selangor (90). The order for making up these reels, Reqn. G&P/Malaya/6/01297/1, was not placed until 1966, again with Harrison. The stamps were joined at the narrow edge. Specimens of each roll were sent to CA (1) and CB (1), so the quantities sent to Malaya on 3 March 1966 were two reels short in each case.

Missing colours:

Missing colours were also frequent on this issue, complicated by the fact that if the black plate was omitted it was often impossible to assign the stamp to a specific state. Some kind of provenance is then needed before the stamp can be confidently ascribed to a state.

The 1c. stamp of Negri Sembilan and the 15c. stamps of Malacca and Selangor are known with the black/grey printing stopping part of the way across the sheet. In the case of the 1c., on some stamps, only the flower name and parts of the flower were omitted. This suggests that two or more overlapping sheets passed through the press together or that the press stopped (or started) part of the way through printing a sheet.

The 6c. Negri Sembilan from an early (Gum Arabic) printing exists with horizontal smudging of the ink affecting the shield and either the top or bottom inscriptions of the stamp.

Plating varieties:

Detailed plating varieties have been studied for this issue by a number of authors, notably Messrs T. C. Masters & J. D. Hastings for Philatelic Society of Malaysia followed by Messrs W. Reeves and B. E. Dexter for Malaya Study Group. Many were very minor and the constancy of some is debatable, due to the nature of the printing process. This was inevitable as plate damage leading to such flaws can occur during the print run and thus appear only on some later sheets. Others may come and go due to the intrusion of dust and other foreign matter into the presses with the paper. The varieties listed below have been segregated by value for the common black and colour plates, and by state for those appearing on the black state duty plates:

Issue & Withdrawal:

The first day cover, sold at 10c., features the flag of Malaysia with the flags of the Member States along the bottom of the cover. No special first day postmark was used. Although the Singapore issue was never released, the rest of the issue was given a philatelic release there, Malaysia and Singapore stamps continuing to be usable in both countries at this time.

For a VIP presentational album of this new issue, see Chapter 77.

The issue was withdrawn on 31 January 1971.

The issue was invalidated for postage from 1 October 1987.

Pos Malaysia issued a blue softback album for collectors of this issue with spaces for both the high values and all the state low values.

Bogus overprint:

Circa 1979, Selangor stamps appeared on the market with single line overprint "PULAU BIDONG", supposedly for use by illegal Vietnamese immigrants on that island. Some mint examples are known, but all values were reported used with postmarks between 1965 and 1971, believed to pre-date the application of the overprint. These overprints were unofficial and stated to be completely bogus.



3. FEDERAL POSTAL STATIONERY.

3.1. POSTCARDS.

The stamp issue was complemented by postal stationery, mainly using similar new designs:

1 April 1967.

Original printing (Type A):

A 139mm x 83mm postcard was printed by an unknown printer in dark blue on low-fluorescence white card, with the Malaysian coat of arms at the left, a "stateless" version of the 10c. Scorpion Orchid definitive (32mm x 22mm, without simulated perforation) at the right and, between them, "POSKAD" over "TULIS 'ALAMAT SAHAJA DI-SINI". It was sold for 12c.


A proof of the postcard was approved by the Crown Agents Inspector of Stamps on 12 May 1966. Two earlier undated design trials have been seen. Printed in green or cyan on the correct size card, they lacked detail on the central and right-hand flowers and the foliage at the bottom of the vignette had not yet been picked out in the detail found on the issued card, rendering it almost invisible. The quality of printing and the shading balance were also improved on the issued cards. ⁶⁹

First day facilities:

No first day facilities were provided for this card.

Reprint (Type B):


The card was reported reprinted in 1968 with a larger crest. This has been seen used on 15 April 1970 at Riverine PO.

3.2. ENVELOPES.


1 April 1967. 15c. Envelope

A 137mm x 108mm white envelope was produced, with only a "stateless" version (32mm x 22mm, without simulated perforation) of the 15c. Foxtail Orchid definitive, printed by an unknown printer in magenta at the top right-hand corner of the envelope. The positioning of the stamp relative to the envelope varied. The envelope was sold at 18c. The white paper had only low fluorescence, but relatively higher and lower fluorescence examples may be found. The flap was triangular with curved end and corners.

There is further evidence to suggest that there were multiple printings of this envelope. Mr. W. Menuz drew my attention to the use of two different screens in the preparation of stamp image, visible under high magnification. On Screen A, a simple diamond-hatched screen was used. On Screen B, it appears that the type of screen used was the type more associated with multicolour printing which creates clumps of dots which merge visually to give the desired colour, giving a more random, speckled effect.



Essays & Proofs:

A proof of the envelope was approved by the Crown Agents Inspector of Stamps on 13 May 1966.

A larger, 156mm x 108mm envelope, said to be a trial printing, exists with a much finer stamp impression than that found on the production envelope. ⁷⁰

Cards exist mint and used (on 27 July 1982) in a darker magenta, believed to be from a trial printing.

First day facilities:

No first day facilities were provided for this envelope.

3.3. AEROGRAMMES.

1 April 1967. 30c. Aerogrammes.

The 25c. rate having become obsolete, a single 30c. aerogramme was issued and sold at face value.

Type I:

The 30c. Blue-backed Fairy Bluebird definitive stamp was reproduced, without simulated perforations, 22mm x 32mm in deep ultramarine on a light cobalt blue sheet (format A, 240mm x 200mm, with gummed tabs having curved ends), with the following text at the top left-hand side of the "front" panel in the dark blue used for the "stamp": "SURAT UDARA / (seagull) / MEL UDARA / PAR AVION / AEROGRAMME". The seagull and following two lines of text were shown in light blue on a dark blue bar which was in turn superimposed on an oval of vertical bars. Three dotted lines for the address, prefixed by "Nama dan 'alamat Pengirim" appear on the back together with four lines of instructions "SURAT UDARA TIADA BOLEH MENGANDONGI / APA2 LAMPIRAN PUN; JIKA DIDAPATI ADA / AKAN DI-KENAKAN BAYARAN LEBEH ATAU PUN / DI-KIRIMKAN DENGAN MEL BIASA".

A proof on blue unwatermarked paper with grainy dark blue printing was approved by Mr. A. S. Fenwick, the Crown Agents Inspector of Stamps on 9 May 1966.

An example of this aerogramme used to India on 13 July 1967 was a darker Navy Blue. This colour change, found on most used examples, is believed to be due to exposure to daylight.

First day facilities:

No first day facilities were provided for this aerogramme.

Type II:

A version on azure unwatermarked paper with much higher definition deep blue printing with unchanged text was approved by R. Wright on 24 July 1967.

Examples of this version are known used between 23 July 1969 and 21 April 1972. The dimension over tabs was 257mm x 212mm (246mm x 197mm without tabs). The tabs were cut at 45 degrees instead of being rounded and the positioning of the bottom row of edging relative to the sides differs from the example of the previous type seen. The stamp was redrawn so that the leaves behind the second bird were fully defined.

Type III:

A third version, as the second but with royal blue text on light blue paper was recorded used between 28 July 1971 and 17 April 1972. The stamp was again coarsely reproduced, with pronounced cross-hatching visible under a magnifying glass, but the leaves and bird were fully defined as on Type II. The tabs were angled as Type II. A key differentiating factor was the position of the vertical fold line. On Types I and II, this coincided with the tip of a blue > on the bottom border of the front panel. On Type III, it was 4mm to the left of the tip, because the width of the blank area of the front panel was increased from 113mm to 117mm.

OPS. Aerogramme (Sabah & Sarawak).



The British GPO-approved (licence no. 71995/IY) Apsley brand air letter was printed in the UK by John Dickinson and was widely available for private purchase and use. It was printed on unwatermarked blue wove paper in four-panel format with narrow tabs at top and right of the front panel. 5000 copies were ordered in December 1965, overprinted by the Government Printer (in Jesselton?) with the address and letterhead of the Borneo Regional Director of Posts and Telecommunications in Jesselton. An example is known used in Jesselton on 29 May 1967 (illustrated), which also bears a promotional handstamp for National Language Week.


3.5. REGISTRATION ENVELOPES.

General Notes: These envelopes were printed by letterpress with the crest embossed. The printer is not known from official records but it was definitely not De La Rue and it was almost certainly McCorquodale for early printings at least. There was no printer's imprint. The designer is similarly unknown.

In comparing these envelopes, it is necessary to take into account that care was rarely taken to ensure consistent positioning of the die-cutters which creates the unfolded envelope relative to the printed paper. This results in wide variations of the positioning of the printed details on envelopes of the same type, as can be seen by the displacement of the blue cross lines where front and back lines overlap (at top and bottom of the front). It is wise to use these cross lines as the basis for comparison, rather than the folded envelope itself. It should be noted that, even where the rest of the printing was substantially different in position, the embossed "stamp" was normally consistently positioned on the flap, indicating that this was done after the envelope blank was cut.

There is also evidence to suggest that the wide variation in appearance of the embossed "stamp" from envelope to envelope is, to a large extent, due to inconsistency in pressure of application of the embossing tool and, in some cases, due to misalignment between upper and lower halves of the die. Die wear may have also played a part in variations.

Registration Envelopes (40s. + 15s.).

This series of envelopes replaced the final Federation of Malaya series, using a similar circular "stamp" design with the new coat of arms, the country name changed from "PERSEKUTUAN TANAH MELAYU" to "MALAYSIA" and the postage rate increased from 10c. to 15c. Like the preceding issue, the crest had straight edges at eight points around its circumference, the east, west, north-east and south-west edges being appreciably longer than the others. This frame was reported to exist rotated so that curves and flats were transposed, but no such example has been seen by the author.

The die proof for the embossed stamp was approved by the Crown Agents Inspector of Stamps on 23 May 1966.

The embossed crest and the letterpress text (which was unchanged from the previous issue) were in deep ultramarine on a flap with rounded corners. The envelope was landscape-format, in Size G (155mm x 95mm - nominally 6in x 3¾in), Size H (203mm x 127mm - 8in x 5in), Size H2 (229mm x 102mm - 9in x 4in) and Size K (292mm x 152mm - 11½in x 6in). They were printed on cream linen-reinforced paper. The paper gave no ultra-violet reaction. There was no watermark. They were sold at 65c. (Size G), 70c. (Sizes H & H2) or 85c. (Size K).

First day facilities:

No first day facilities were provided for this envelope.

Revised die:

A later printing, circa late 1969, in slightly duller colours was reported to have a new embossed die. ⁷¹ The straight edges were more or less equal in length and the whole design was clearer and bolder in appearance. These were put on sale as older stocks were exhausted, without an official release date. Copies of this printing would usually be found with 20c. adhesive stamps being attached as the registration fee rose from 40c. to 60c. on 8 July 1968. The late Mr. Ian Raybould reported a Size G envelope with two 10c. stamps used in Kelantan on 6 July 1968, two days prior to the reported effective date of the rate change.

The envelopes were reissued in 1970 with the increased registration fee. The crest was embossed, and the text printed, in deep ultramarine on cream linen-reinforced paper. The ink colour changed over the life of the issue, becoming ultramarine by October 1971. The envelope was landscape-format, in Sizes G (sold at 85c.), H (90c.), H2 (90c.) and K (\$1.05). The text was unchanged, but the text on the reverse was in upper case on Size G and H, and in mixed upper and lower case on Size K. Size H2 envelopes were recorded but no example has been seen by the author. On Sizes G and H, the top centre scroll ends of the "stamp" point upwards, but on Size K they point downward. This Size K envelope was still on sale as late as August 1978.

Variety:

The size G envelope is known with all printing, except the "stamp", omitted. This is known mint and commercially used on 13 November 1975

Reengraved Die:




The embossing tool for the envelopes was reengraved, reputedly in 1971, although the earliest seen by the author was used on 4 January 1974. The new crest has the coat of arms more clearly defined but the most obvious difference was in the scrolled ornament of the outer ring, particularly near the top where they were much bolder in the redrawn die. The crest was embossed, and the text printed by letterpress, in blue instead of ultramarine. The envelope was landscape-format, in Sizes G, H, H2 and K, printed on cream linen-reinforced paper. The 1971 Post Office Guide and the 1971 edition of the Post Office Rules 1947 both refer to a Size K1 envelope, size $9\frac{1}{4}$ in x $4\frac{3}{4}$ in, on sale at 95c., but no copies have been seen by the author and no other reference to such an envelope has been found.

An example of this Size G envelope seen used on 12 October 1974 from Kuala Krai, Kelantan, had the die struck in a lighter blue ink on a lighter cream paper which showed fluorescence under ultra-violet light.

Economised envelope (1975):

The envelopes were reissued by February 1975 without linen-reinforcement, in the interests of economy. The non-fluorescent cream paper has a pale greenish-blue interior to aid opacity. One Size G was known used on 11 May 1976 on white/pale blue paper, which could be a colour changeling.

The text was revised to follow the new Bahasa Malaysia language rules instead of Romanised Malay (an easy distinguishing factor was the lack of hyphenated words in the text of new version). The box for the registration label was inscribed "Ruangan ini dikhaskan / untuk Lebel Pendaftaran / Rasmi. / Sampul surat G.". The front was headed "SURAT BERDAFTAR / SURAT INI HENDAKLAH DISERAHKAN KEPADA / PEGAWAI PEJABAT POS UNTUK DIDAFTARKAN / DAN AMBIL RESIT DARIPADANYA.", above "KEPADA" and four lines for the delivery address. The back read "NAMA DAN 'ALAMAT PENGIRIM" (mixed font in the case of Size K) above "DARIPADA" and four lines for the sender's address.

The (again redrawn) embossed crest and text were in dull ultramarine. There is evidence that at least two dies were in simultaneous use. On Sizes G and H and some Size K (an example exists bought in August 1979), the top centre scroll ends of the "stamp" pointed upwards (Die I), but on other Size K (seen used on 22 February 1979 and bought between January 1980 and May 1981) they once again pointed downward (Die II). The envelope was landscapeformat, in Sizes G (known mint annotated "Bought Feb 1975"), H (exists mint annotated "Bought Feb 1975") and K (earliest reported used on 22 February 1979). This value was phased-out at around this time. Sale prices were unchanged.

Shades of ink and print quality varied over time. Examples of Size G seen purchased in August 1978 showed the text lower (with lines failing to reach the top of the front) and "dotted" lines flowing together in places to form full lines. By contrast, examples of Size H from the same date showed a much clearer die impression than 1975 examples, having been impressed more deeply.

Varieties:

A Size G envelope was used on 1 August 1978 at Setapak with all printing omitted except the "stamp". 73

A Size K envelope is known, purchased in May 1981, with the "stamp" misplaced upwards to only 1mm from the flap edge (normally 6mm).



Redrawn Size K envelope and New Die (1981-1982):

Shortly before the introduction of the ISO envelope described below, the Size K envelope was completely redrawn with "SURAT BERDAFTAR" in a normal font instead of the condensed font hitherto used for Size K envelopes. The envelope was printed in dark blue on light blue paper. The embossing die was again heavily redrawn without the thin outer ring previously used. The supporters of the crest were more detailed, especially their back shading. The top centre scroll ends pointed upwards again. An example exists annotated "Bought 4 April 1982". The flap of the envelope had sharp corners instead of rounded.



A further printing, circa 1981, had a redrawn crest with curved edges all around its circumference, instead of alternating straight and curved, the very thin ring omitted and the text in very small characters, allowing a space $3\frac{1}{2}$ mm either side of the dots between "MALAYSIA" and the rest of the text. The front vertical line no longer cut through the text on Size G (but still did on Size K) and the text was centralised on that size. It was printed in ultramarine on light blue fluorescent paper. Flap corners were once again rounded.

These envelopes had revised sizes, based on ISO envelope sizes. The sizes were now G (6½ in x 4½ in, 165mm x 114m, C6), H (8½ in x 4¼ in, 216mm x 108mm, approximately DL), K (11½ in x 6½ in, 229mm x 162mm, approximately C5). They were otherwise similar to the preceding issue. The sale price of the new sizes is not known, but was believed to be 80s. for Size G. A Size G is known used on 13 June 1981. A Size H has been seen used on 24 August 1983 at Kuching APO. A Size K exists annotated "Bought 21 August 1982".

An envelope in the same style but the Old Size G has been reported used 9 December 1980. 74


The ISO Size G, H and K envelopes were reissued in 1982 with a revised crest having larger lettering, leaving no space between the text and "MALAYSIA" (a large dot was used to separate them, that on the left having an additional small dot). The coat of arms was larger and bolder, just touching the circle of dots, but the lower right was not printed clearly due to die misalignment or wear. A new font was used, with no apostrophe before "ALAMAT" on the back. The text was in grey-blue with thicker vertical and horizontal lines on Size G. They were printed on light grey-blue fluorescent paper, with light blue interior as before. Size G is known used on 27 August 1982. An example of Size K was found annotated "bought 28 June 1983 in Penang". The sale price of the new sizes is not known, but was believed to be 80s. for Size G.

First die (1983):

The Size G, H and K envelopes were reissued in 1983 with the postage rate raised from 15s to 20s., the postage rate having risen on 1 January 1983. The earliest reported used examples dated from 1 March 1984 (Size G) or 3 December 1985 (Size K). They were sold at 90c., 95c. and \$1.10 respectively. There was no apostrophe before ALAMAT in the text on the back. (I.S.C. listed Size G with and without the apostrophe, but this change took place prior to the rate change on Size K at least.) The embossed crest and text were in dull ultramarine. They were printed on bluish-white un-reinforced paper with a light greenish-blue inner face.

Second die (1985?):

The Size G at least was reprinted by June 1985 (earliest seen used on 28 June) with a completely redrawn die in which the tigers' head was leant forward towards the star (as in the \$1+20s. below), instead of being erect as on all previous dies. The Size G was without an apostrophe before ALAMAT in the text on the back. The embossed crest and text were in dull ultramarine. They were printed on cream un-reinforced paper with a light green inner face.



The registration fee was raised from 60s to \$1, effective from 1 February 1985. The Size G, H and K envelopes were then sold at \$1.30, \$1.35 and \$1.50 respectively. Size G and K envelopes at least were reprinted. The Size H envelope has only been seen in Type 3 form. The new envelope was landscape-format. There was no watermark. There was a fifth address line added to the back for the postcode, prefaced by the word "POSKOD". It has been suggested that this postcode line was not present on early printings, but no examples without it have been seen by the author.

At least three distinct printings have been identified.

1. 1985 Printed in dull ultramarine on bluish-white un-reinforced ordinary paper with a light blue-green textured inner face (Size G seen used on 1 January 1986).
